1. A prov. panel part-1 of 16 employees (UR-10, OBC-3,SC-3) was declared on 27-09-2023. However, empanelment of 2 employees ( UR-1,SC-1) is cancelled as they have not fulfilled eligibility norms. Details are enclosed as "Corrigendum to Prov. panel part-1" ( **Annx.1** ). Accordingly, number of employees empaneled in prov. Panel part-1 revised as 14 (UR-9, OBC-3,SC-3).
2. In continuation to this, a prov. Panel part-2 of 4 employees (UR-2,OBC-1,SC-1) is declared subject to condition that employees found fit in Aye Three. Employees called for DV of Commercial Clerk but not considered for empanelment for Commercial Clerk were considered for Trains Clerk based on their merit. Also, 1 OBC employee of prov. Panel part-1 is now considered as UR.

4. Details of vacancies notified, no. of employees empaneled in prov. panel part-1 is as under:


