DECLARATION OF PROVISIONAL PANEL PART-4 CEN 02/2018 (Level - 1 Posts of 7th CPC Pay Matrix)

1. Railway Recruitment Cell, Western Railway had declared the Provisional Panel Part-1 of 4050 Non PwBD candidates on 8-5-19 & Provisional Panel Part-2 of 805 Non PwBD candidates on 26-6-2019. Names of 9 candidates who were inadvertently empanelled in Provisional Panel Part-1 had been deleted vide Corrigendum dated 31-7-19.
2. Further, RRC-WR has conducted Document Verification (2nd Stage) of 169 Non PwBD candidates on 8th & 9th July'2019, (3rd Stage) of 235 Non PwBD candidates from 7th Aug. to 9th Aug.'2019 and (4th Stage) of 169 Non PwBD candidates on 16th Sept. & 17th Sept.'2019
3. On completion of the formalities as per the procedure laid down by Railway Board, Railway Recruitment Cell, Western Railway further declares the Provisional Panel Part-4 of 137 Non PwBD candidates & 48 PwBD candidates (LD - 4 , VI – 42 ,HI -2) on 31-10-2019.

8. This is only a Provisional Panel and NOT THE FINAL PANEL which does not confer upon the candidates any right for appointment in Railway Service.
