FOR CANDIDATES WHO REMAINED ABSENT  
DURING 11<sup>th</sup> STAGE DOCUMENT VERIFICATION (Non PwBD),  
12<sup>TH</sup> stage DOCUMENT VERIFICATION**

**A. For Absent candidates of 11<sup>th</sup> stage DV**

1. 11<sup>th</sup> stage Document Verification of 78 (UR - 48, OBC - 17, SC - 7, ST - 6) non PwBD candidates was conducted on 12<sup>th</sup> & 13<sup>th</sup> July'2022. 32 ( UR-20,OBC- 8,SC-3 , ST-1) non PwBD candidate were remained absent during the 10<sup>th</sup> stage Document verification.
2. These **32** candidates will be given the **2<sup>nd</sup> and final** chance to attend the Document Verification scheduled to be held on **11-10-2022** at the office of Railway Recruitment Cell, Western Railway, Grant Road, Mumbai.
3. Concerned candidates should attend RRC office for Document Verification with all their Certificates in Original. No further chance shall be given to candidates who will remain absent on **11-10-2022**.

**B. For Candidates of 12<sup>th</sup> Stage DV**

1. 269 non PwBD candidates (UR - 124, OBC -83, SC -35, ST -27) are being called for 12<sup>th</sup> stage DV against Replacement Indent received from HQ office. Some candidates from OBC merit are now considered in UR merit.
2. Dates of DV : 11<sup>th</sup> Oct.'2022 to 14<sup>th</sup> Oct.'2022
3. Document Verification will be held at RRC Office, Grant Road, Mumbai. Candidates may refer to "Cut off marks" uploaded separately on website to know their eligibility status for DV. Candidates may note that some candidates from OBC merit are now eligible under UR merit and accordingly called for DV in UR merit.

### **C. Common Instructions**

1. Call letter to eligible candidates will be made available shortly on RRC-WR's website. Candidates can also see "Venue of medical examination" at the time of downloading call letter.
2. Candidates found eligible in Document Verification will be directed for medical examination to nominated Railway Hospital at Mumbai, Vadodara, Ahmedabad. They are advised to plan their journey from Mumbai to their "Venue of Medical Examination" in advance. Candidates are advised to come prepared for stay at concerned venue for 3-4 days.
3. Request for change of "Venue of Medical examination" will not be considered.
4. Candidate must bring following Certificates in Original along with two sets of Photocopies of all Documents duly self-attested mentioned as under:
  - (A) Mark Sheets Certificates of all Educational / Technical qualification mentioned in the Application / Notification. Gazette Notification and / or any legal Document in case of formal change of Name as mentioned in Notification.
  - (B) Certificate for proof of Date of Birth as mentioned in the Notification in absence of relevant Date of Birth Certificate Candidature of Candidate will be Cancelled (Birth Certificate will not be considered as valid documentary proof).
  - (C) Caste Certificate for SC / ST / OBC Candidate in prescribed format issued by Competent Authority, OBC Candidates are required to produce current (not prior to 2021 – 2022) OBC Caste Certificate in prescribed format which should have clear mention about Non – Creamy Layer status.
  - (D) Lower half portion of Admit Card of Written Examination and Physical Efficiency Test (PET).
  - (E) No Objection from Controlling Officer in case of Government Servant.
  - (F) Discharge Certificate / NOC in case of Ex-Servicemen (Ex-SM).
  - (G) Disability Certificate in case of PwBD Candidates, Income Certificate in case of EBC, Minority Declaration (Affidavit) in case of Minority Candidate.
  - (H) Photo Identity Card as mentioned in CEN No. 02/2018 (any One) and photo copy of both side of Aadhar Card with Original.
  - (I) Receipt of Payment if made through a challan at SBI Branch or Pay – in – Slip at computerized Post Office.
  - (J) Income Certificate for Waiving Examination Fee for Economically Backward Classes as per Annexure – III of CEN 02/2018
  - (K) Minority Community declaration on Non - judicial Stamp Paper as per Annexure – IV of CEN 02/2018
  - (L) Self-Certification by the Transgender Candidate.
  - (M) J&K domicile Certificate.
  - (N) Decree of Divorce / Judicial Separation from the Competent Court of law as applicable and Affidavit stating that the Candidate has not re-married.
  - (O) In case of Widow, Death Certificate of Spouse and Affidavit stating that the Candidate has not re-married.

5. **Candidates are also required to carry 6 copies of photographs similar to scanned copy of photograph uploaded in ONLINE Application Form and 6 copies of latest photographs (Photograph taken after 23-09-2022).**
6. Candidates may please note that merely being called for Document Verification does not confer any right for appointment to the notified posts.

**SPECIAL INSTRUCTIONS IN VIEW OF COVID-19**

- Candidates will have to follow the SOPs as per existing guidelines issued by the Maharashtra Government from time to time for their DV at Mumbai and also of concerned State Governments for their Medical Examination. For this, required arrangements have to be done by the candidates themselves.
- Candidates must wear Face Mask and carry Hand Sanitizer.
- Candidates must maintain physical distancing at all times.
