1. RRC-WR has declared Provisional Panel Part-1 of 4050 candidates on 08/05/2019 against CEN 02/2018 wherein the following 09 candidates were inadvertently empanelled :-

2. Accordingly, in terms of para 5 of Notification dt. 8-5-19 ( Declaration of Prov. Panel Part-1), names of these 9 candidates are now deleted from Provisional Panel Part-1 for the reasons mentioned against each.
3. Details of empanelled candidates in Provisional Panel Part-1 after deletion of these 9 candidates:- **UR-2057,OBC-904,SC-579,ST-327,Ex-serviceman-31, CCAA-143 ,Total 4041**
4. One Candidate (Roll No. 112023092520020,Sr.No.2 ) was subsequently declared FIT in medical examination and empanelled in Prov. Panel Part-2 declared on 28-6-2019.
5. Candidature of one Candidate (Roll No. 112004080010083,Sr.No.1) is cancelled being not eligible against CCAA quota.
6. Remaining seven Candidates ( Sr.no.3 to 9 ) may be considered for empanelment subject to fulfilling of prescribed norms.
