**FOR CANDIDATES WHO REMAINED ABSENT DURING 9th STAGE DOCUMENT VERIFICATION (Non PwBD)
& 5th Stage for PwBD Candidates**

1. 9th stage Document Verification of 362 non PwBD candidates and 5th Stage DV for 48 PwBD candidates was conducted on from 22nd Sept.'2021 to 12th Oc'2021. 147 (UR- 94 ,OBC-27 ,SC- 17, ST- 9) non PwBD candidate and 29 PwBD candidates were remained absent during the 9th stage Document verification.
2. These 176 candidates (Non PwBD-147, PwBD-28) will be given the **2nd and final** chance to attend the Document Verification scheduled to be held on **25-10-2021, 26-10-2021 and 27-10-2021** at the office of Railway Recruitment Cell, Western Railway, Grant Road, Mumbai.
3. Concerned candidates should attend RRC office for Document Verification with all their Certificates in Original. No further chance shall be given to candidates who will remain absent on scheduled dates .
4. Candidates found eligible in Document Verification will be directed for medical examination at Mumbai / Vadodara/ Ahmedabad / Ratlam for which they may have to stay for 3-4 days. Candidates are advised to come prepared accordingly. Request for change of "Venue of Medical examination" will not be considered.
5. Candidates must carry all the Original Certificates mentioned in the "INSTRUCTION FOR CANDIDATES" of Call Letter. **Candidates are also required to carry 6 copies of photographs similar to scanned copy of photograph uploaded in ONLINE Application Form and 6 copies of latest photographs (Photograph taken after 1-9-2021).**
6. Candidates may please note that merely being called for Document Verification does not confer any right for appointment to the notified posts.

SPECIAL INSTRUCTIONS IN VIEW OF COVID-19

- Candidates will have to follow the SOPs as per existing guidelines issued by the Maharashtra Government from time to time for their DV at Mumbai and also of
