**NOTICE FOR 10<sup>TH</sup> DOCUMENT VERIFICATION**

1. After empanelling 5883 candidates (Non PwBD - 5746, PwBD -137) in 10 Prov. Part panels, balance 224 candidates (Non PwBD- 8, PwBD-196) are to be empaneled.175 candidates are also empaneled in Repl. Panel- Part 1.
2. Considering balance vacancies (including vacancies of Replacement Indent) and pending cases of some candidates of earlier DVs, **157** non PwBD candidates (UR - 105, OBC - 26, SC - 17, ST - 9) and 26 PwBD candidates (LD - 6, VI - 8, HI - 12) are being called for 10<sup>th</sup> stage of Document Verification.
3. Dates of DV: **4<sup>th</sup> Jan'2022 to 6<sup>th</sup> Jan'2022**
4. Document Verification will be held at RRC Office, Grant Road, Mumbai. Candidates may refer to "Cut off marks" uploaded separately on website to know their eligibility status for DV. Candidates may note that some candidates from OBC merit are now eligible under UR merit and accordingly called for DV in UR merit.
5. Call letter to eligible candidates will be made available shortly on RRC-WR's website. Candidates can also see "Venue of medical examination" at the time of downloading call letter.
6. Candidates found eligible in Document Verification will be directed for medical examination at nominated Railway Hospital. They are advised to plan their journey from Mumbai to their "Venue of Medical Examination" in advance. Candidates are advised to come prepared for stay at concerned venue for 3-4 days.
7. Request for change of "Venue of Medical examination" will not be considered.
8. Candidate must bring following Certificates in Original along with two sets of Photocopies of all Documents duly self attested mentioned as under:
  - (A) Mark Sheets Certificates of all Educational / Technical qualification mentioned in the Application / Notification. Gazette Notification and / or any legal Document in case of formal change of Name as mentioned in Notification.
  - (B) Certificate for proof of Date of Birth as mentioned in the Notification in absence of relevant Date of Birth Certificate Candidature of Candidate will be Cancelled (Birth Certificate will not be considered as valid documentary proof).

- (C) Caste Certificate for SC / ST / OBC Candidate in prescribed format issued by Competent Authority, OBC Candidates are required to produce current (not prior to 2021 – 2022) OBC Caste Certificate in prescribed format which should have clear mention about Non – Creamy Layer status.
  - (D) Lower half portion of Admit Card of Written Examination and Physical Efficiency Test (PET).
  - (E) No Objection from Controlling Officer in case of Government Servant.
  - (F) Discharge Certificate / NOC in case of Ex-Servicemen (Ex-SM).
  - (G) Disability Certificate in case of PwBD Candidates, Income Certificate in case of EBC , Minority Declaration (Affidavit) in case of Minority Candidate.
  - (H) Five identical passport size Photographs same as uploaded with the Application and also five latest / current passport size Photograph bring the Candidates at the time of Document Verification.
  - (I) Photo Identity Card as mentioned in CEN No. 02/2018 (any One) and photo copy of both side of Aadhar Card with Original.
  - (J) Receipt of Payment if made through a challan at SBI Branch or Pay – in – Slip at computerized Post Office.
  - (K) Self Certification by the Transgender Candidate.
  - (L) J&K domicile Certificate.
  - (M) Decree of Divorce / Judicial Separation from the Competent Court of law as applicable and Affidavit stating that the Candidate has not re-married.
  - (N) In case of Widow, Death Certificate of Spouse and Affidavit stating that the Candidate has not re-married.
9. **Candidates are also required to carry 6 copies of photographs similar to scanned copy of photograph uploaded in ONLINE Application Form and 6 copies of latest photographs (Photograph taken after 15-12-2021).**
10. Candidates may please note that merely being called for Document Verification does not confer any right for appointment to the notified posts.

#### **SPECIAL INSTRUCTIONS IN VIEW OF COVID-19**

- Candidates will have to follow the SOPs as per existing guidelines issued by the Maharashtra Government from time to time for their DV at Mumbai and also of concerned State Governments for their Medical Examination. For this, required arrangements have to be done by the candidates themselves.
- Candidates must wear Face Mask and carry Hand Sanitizer.
- Candidates must maintain physical distancing at all times.
