- 1. Railway Recruitment Boards (RRBs) have conducted CBT from 17-8-2022 to 11-10-2022 and published result of CBT on 22-12-2022. In terms of Item (3) & (4) of RRB-Ahmedabad's notice, further communication reg. conduct of PET, Document Verification, Medical examination and publishing of Panel shall be done by RRC-Western Railway.
- Accordingly, Document Verification of 324 PwBD candidates (LD-107, VI-175, HI-34, MD-7, Ex-SM (HI)-1) and 1240 CCAA candidates is scheduled form 30-01-2023 to 08-02-2023 at RRC Office, Grant Road, Mumbai.
- **3.** PwBD candidates are shortlisted for DV based on the Normalized marks of CBT and CCAA candidates are shortlisted for DV based on the 2/3rd of Weighted Normalized Marks of CBT ' + 1/3rd of Scaled NCVT Marks.

6. Common Instructions

- i) Candidates found eligible in Document Verification will be directed for medical examination at nominated Railway Hospital. They are advised to plan their journey from Mumbai to their "Venue of Medical Examination" in advance. Candidates are advised to come prepared for stay at concerned venue for 3-4 days.
- ii.) Request for change of "Venue of Medical examination" will not be considered.
- iii.) Candidate must bring copy of **Application Form** and following Certificates in Original along with two sets of Photocopies of all Documents duly self attested mentioned as under:
 - (A) Mark Sheets and Certificates of all Educational / Technical qualification mentioned in the Application Form / Notification.
 - (B) Gazette Notification and / or any legal Document in case of formal change of Name as mentioned in Notification.
 - (C) NCVT (NTC/NAC) /SCVT certificate and mark sheet for CCAA candidates
 - (D) Certificate for proof of Date of Birth as mentioned in the Notification. In absence of relevant Date of Birth Certificate, candidature of Candidate will be Cancelled (Birth Certificate will not be considered as valid documentary proof).
 - (E) Caste Certificate for SC / ST (as per Annx. I of Notification), OBC Candidate (as per Annx. II of Notification) in prescribed format issued by Competent Authority. OBC Candidates are required to produce current (not prior to 2022 2023) OBC Caste Certificate in prescribed format which should have clear mention about Non Creamy Layer status (as per Annx. II A of Notification).
 - (F) Income and Asset Certificate for Economically Weaker Section (EWS) (as per Annx. III of Notification).
 - (G) NOC from serving employees with Date of Appointment from current employer
 - (H) Self-Declaration (as per Annx. VII) and Discharge Certificate / NOC in case of Ex-Servicemen
 - (I) Disability Certificate in case of PwBD Candidates (as per V(A), V(B), V(C) of Notification).
 - (J) Photo Identity Card as mentioned in CEN No. RRC-01/2019 (any One) and photo copy of both side of Aadhar Card with Original.
 - (K) Receipt of Payment if made through a challan at SBI Branch or Pay in Slip at computerized Post Office.
 - (L) Income Certificate for Waiving Examination Fee for Economically Backward Classes as per Annexure – III A
 - (M) Minority Community declaration on Non judicial Stamp Paper as per Annexure IV of Notification.
 - (N) Self-Certification by the Transgender Candidate.
 - (O) J&K domicile Certificate wherever applicable
 - (P) Decree of Divorce / Judicial Separation from the Competent Court of law and Affidavit stating that the Candidate has not re-married, in case applicable.
 - (Q) In case of Widow, Death Certificate of Spouse and Affidavit stating that the Candidate has not re-married
- iv.) Candidates are also required to carry 6 copies of photographs similar to scanned copy of photograph uploaded in ONLINE Application Form and 6 copies of latest photographs
