- (M) Income Certificate for Waiving Examination Fee for Economically Backward Classes as per Annexure - III A
- (N) Minority Community declaration on Non judicial Stamp Paper as per Annexure IV of CEN
- (O) Self-Certification by the Transgender Candidate.
- (P) J&K domicile Certificate, if applicable
- (Q) Decree of Divorce / Judicial Separation from the Competent Court of law and Affidavit stating that the Candidate has not re-married, in case applicable.
- (R) In case of Widow, Death Certificate of Spouse and Affidavit stating that the Candidate has not re-
