- 1. As per the GM(E) –CCG's notifications referred at (1) & (2) above, 7 posts (UR-3,OBC-2, SC-1, ST-1) of Junior Clerk cum Typist (GP Rs.1900/-) and 21 posts (UR-8,OBC-7, SC-4, ST-2) of Ticket Examiner (GP Rs.1900/-) had been notified.
- 2. Computer Based Test (CBT) for the post of Junior Clerk Cum Typist & Ticket Examiner was held on 13-9-2019. Revised result of CBT was declared on 12-12-2019 in which 56 employees were qualified for Typing Test for the post of Junior Clerk Cum Typist and 32 employees (Regular List 21 ,Additional List -11) were qualified for Document Verification for the post of Ticket Examiner.
- 3. Online Typing Test for the post of Junior Clerk cum Typist was held on 26-12-2019. 12 employees were qualified in Typing Test. Amongst 12 employees qualified in Typing Test, 10 employees (Regular List 7, Additional List -3) employees were qualified for Document Verification.
- 4. Document Verification for both the posts was held on 17-3-2020 at RRC office, Grant Road.
- 5. After verification of original documents and in compliance of the procedure laid down by Railway Board, Railway Recruitment Cell, Western Railway declares the Provisional Panel. Details are as under.
