NOTICE OF AMENDMENT

Ref: 1) Railway Board's letter no. 2021/E(sports)/RSPB/4(1)/2/Status dated 31-7-2023.

- 2) Railway Board's letter No. 2025/E(Sports)/04/10/NSF dated 22-8-2025.
- 3) Railway Board' letter No. 2021/E(sports)/RSPB/4(1)/2/Status dated 26-8-2025.

The following amendments are incorporated in the para indicated as below in the Employment notice No RRC/WR/01/2025 (Sports) Quota dated 29-7-2025:

- 1) Para 3.4.7 of Employment Notice No. RRC/WR/01/2025 (Sports Quota) Dated 29-07-2025 may be read as:
 - "Participation and medal-winning performances in events organized by the Handball Association of India on or after 25.07.2023 will be considered for recruitment of sportspersons in Indian Railways; However, those held on or after 05.09.2023 will not be considered." (i.e. Participation and medal-winning performances in events organized by the Handball Association of India will only be considered from 25-7-23 to 4-9-23)
 - Certificates issued for events conducted under the aegis of the Association of Indian Universities and recognized International Sports Federations in the game of Handball will, however, continue to be considered valid."
- 2) The following is added as Note 1 under Para. 3..3 of Employment Notice No. RRC/WR/01/2025 (Sports Quota) Dated 29-07-2025:
 - All Championship should be conducted under the aegis of recognized International/National Sports Federations and also recognized by the Railway Sports Promotion Board. In cases of international sports events, if a sportsperson has represented the country with the sanction of Government/Sports Authority of India in the event, then his/her achievement shall be considered for recruitment irrespective of the status of recognition of NSF of that sports discipline.
- 3) In view of the above amendment, the <u>option to edit / modify</u> the application is granted from <u>11-9-2025</u> (11.0 hrs) to 17-9-2025 (16.00 hrs), only to those <u>candidates who have already submitted</u> the applications on or before 29-8-2025 till 18.00 hrs
