- 1 The Written Test for Level 2 post against Recruitment against Cultural Quota was held on 21-02-2026.
- 2 The answer Key was notified vide notice dated 23-02-2026 & objections / claims if any with regard to answer key or question Paper of the Written Test held for Level - 2 post against Cultural Quota was called for till 26-02-2026.
- 3 No objection received from candidate till 26.02.2026 against notified answer key published on the website. Therefore the answer key published vide notice dated 23-02-2026 is the final answer key.
- 4 Result of Written Test held on 21-02-2026 for recruitment against Cultural Quota for the year 2025-2026 for 2 posts in Level 2 is notified. The result of successful candidates is only provisional & is attached as **Annexure A. No candidate is found eligible for Keyboard Synthesizer Player Discipline).**
- 5 List of qualified candidates is not as per merit but as per Registration no as arranged in ascending order.
- 6 The candidate at Sr. No. 2 in the list was declared as Provisionally Eligible in the Eligibility List published on 27-01-2026 due to old OBC Caste certificate. In terms of Para – 7.14 (e) of the notification, OBC certificate with non-creamy layer certificate valid for the current year 2025-2026 in Central Government format is required at the time of Document Verification. In case of non submission of this certificate at the time of Document Verification, her candidature will be treated as cancelled.
- 7 Qualified candidates are advised to appear **Document Verification / Practical Demonstration Test on 23-03-2026 at 12.30 hrs, Venue : Western Railway, Rail Nikunj Hall, Opposite Divisional Railway Manager Office, Near Railway Dispensary, Mumbai Central, Mumbai - 400 008.**

- 8 Candidates are advised to bring all their Original Certificates / Documents along with 2 self attested Xerox copies there of uploaded at the time of online application.
 - i. Printed copy of downloaded application.
 - ii. All original certificates uploaded at the time of online application. Academic Educational Qualification certificates & Cultural Qualification certificate, and Prizes & Award certificates of competitions held in College, Inter University or State Level. Certificates for performance done in AIR or Doordarshan.
 - iii. Candidate should furnish caste certificate from Competent Authorities as per the prescribed formats in the notification (for SC / ST / OBC - NCL (Non Creamy Layer for current financial year i.e. issued on or after 01/04/2025) wherever applicable.
 - iv. "No Objection Certificate" from the employer, if already in service of PSU / Government Organizations.
- 9 Please also note that no supplementary Document Verification & Practical Demonstration Test shall be held.
- 10 In case they fail to attend for Document Verification & Practical Demonstration Test on the scheduled dates or unable to produce the required documents, their candidature will be cancelled. Candidate may have to stay for 2 - 3 days if necessary so they are advised to come prepared accordingly.
- 11 The Call Letter for Document Verification / Practical Demonstration Test will be available shortly.
- 12 For Practical Demonstration Test, candidates are required to bring their own musical instrument etc as applicable
- 13 While due care has been taken in preparing in the result, in case of any inadvertent errors is noticed at any stage, RRC - Western Railway reserves the right to rectify it at later stage of selection procedure.
