1. After declaration of provisional panel part-8, RRC-WR has conducted Document Verification of 36 non PwBD candidates ( 8<sup>th</sup> stage ) on 6/7-07-2021 and on 28-07-2021 (2<sup>nd</sup> & Final chance for absentees ). Pending cases of some candidates of earlier DVs have also been finalized.
2. On completion of the formalities as per the procedure laid down by Railway Board, Railway Recruitment Cell, Western Railway further declares the Provisional Panel Part-9 of 26 non PwBD candidates & 3 PwBD candidates on 12-08-2021.
