## FOR CANDIDATES WHO REMAINED ABSENT DURING 9<sup>th</sup> STAGE DOCUMENT VERIFICATION (Non PwBD) & 5<sup>th</sup> Stage for PwBD Candidates

- 9<sup>th</sup> stage Document Verification of 362 non PwBD candidates and 5<sup>th</sup> Stage DV for 48 PwBD candidates was conducted on from 22<sup>nd</sup> Sept.'2021 to 12<sup>th</sup> Oc'2021. 147 (UR- 94 ,OBC-27 ,SC- 17, ST- 9) non PwBD candidate and 29 PwBD candidates were remained absent during the 9<sup>th</sup> stage Document verification.
- These 176 candidates (Non PwBD-147, PwBD-28) will be given the 2<sup>nd</sup> and final chance to attend the Document Verification scheduled to be held on 25-10-2021, 26-10-2021 and 27-10-2021 at the office of Railway Recruitment Cell, Western Railway, Grant Road, Mumbai.
- Concerned candidates should attend RRC office for Document Verification with all their Certificates in Original. No further chance shall be given to candidates who will remain absent on scheduled dates.
- 4. Candidates found eligible in Document Verification will be directed for medical examination at Mumbai / Vadodara/ Ahmedabad / Ratlam for which they may have to stay for 3-4 days. Candidates are advised to come prepared accordingly. Request for change of "Venue of Medical examination" will not be considered.
- 5. Candidates must carry all the Original Certificates mentioned in the "INSTRUCTION FOR CANDIDATES" of Call Letter. Candidates are also required to carry 6 copies of photographs similar to scanned copy of photograph uploaded in ONLINE Application Form and 6 copies of latest photographs (Photograph taken after 1-9-2021).
- 6. Candidates may please note that merely being called for Document Verification does not confer any right for appointment to the notified posts.
